



**Terms & Conditions**  
**2025 VRC Member MCG Match Day Event Registration**

These Terms & Conditions apply to all VRC members and their guests.

<b>A. Event:</b>	2025 VRC Member MCG Match Day Event, Sunday 18 May 2025
<b>B. Eligible Entrants</b>	<p>Event Registration is only open to individuals who are:</p> <ul style="list-style-type: none"><li>a. a fully financial Victoria Racing Club (“VRC”) Member for the 2024/25 Racing Season and must fall into one of the below Member Categories:<ul style="list-style-type: none"><li>a. Full</li><li>b. Restricted</li><li>c. Life</li><li>d. Pre-79</li><li>e. Young</li><li>f. Young Restricted</li></ul></li><li>b. <b>not</b> employees of the Promoter, its associated companies/subsidiaries or agencies associated with this Event; and</li><li>c. <b>not</b> immediate family or members of the same household of persons referred to in paragraph b) above.</li></ul> <p>“Employees” means any directors, management, employees, concessionaires, consultants, officers and contractors or other such people who perform work under the control of another in exchange for payment.</p> <p>“Immediate family” means any of the following: spouse, ex-spouse, de-facto spouse, child or stepchild (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.</p> <p>Victoria Racing Club is responsible for determining whether a person is an Eligible Entrant in its absolute discretion.</p>
<b>C. Registration Period</b>	<p><b>Entries Open:</b> 10:00am (AEST) Tuesday 8 April 2025</p> <p><b>Entries Close:</b> 10:00am (AEST) Tuesday 15 April 2025</p>
<b>D. How to Register:</b>	<p><b>Online Registration</b></p> <p>For the most efficient registration process, Eligible Entrants are required to complete the online registration via <a href="http://vrc.com.au/forms/mcg-match-day-registration-form/">vrc.com.au/forms/mcg-match-day-registration-form/</a></p> <p>Members are eligible to register to attend the Event for themselves and one (1) guest.</p> <p>The following steps will be required to complete an online registration:</p> <ul style="list-style-type: none"><li>1. Enter your personal details<ul style="list-style-type: none"><li>a. First Name</li><li>b. Last Name</li><li>c. Member Number</li><li>d. Email (the one linked to your VRC Membership)</li><li>e. Contact Number</li></ul></li><li>2. Select your tickets.<ul style="list-style-type: none"><li>a. A maximum of 2 (two) tickets per registration.</li></ul></li><li>3. 	<p>4. Submit Registration</p> <p>A confirmation message will appear to confirm a successful registration in the random draw.</p> <p>Places at the Event are subject to availability. For the avoidance of doubt, a successful registration does not guarantee a ticket to the Event.</p> <p>Please note: While the Club's Membership Services team members can assist in troubleshooting registrations, they are unable to take registrations over the phone.</p>
<b>E. Draw Details:</b>	<p>The random draw will be conducted on Wednesday 16 April at 11:00am AEST.</p> <p><b>How the Draw works</b></p> <p>Following the conclusion of the registration period, registrations will be randomly selected for allocation of tickets to the Event (<b>Ticket(s)</b>).</p> <p>This process gives each registration an equal chance of success.</p> <p>Notification of the outcome of the draw (successful or unsuccessful) will be communicated via email by 5:00pm AEST Thursday 17 April to members who provided an email address.</p>
<b>F. Ticket Details:</b>	<p>Eligible Entrants who have been successful in securing place at the Event (<b>Successful Entrant</b>) will be notified as soon as reasonably practicable following the Closing Date via email to the Successful Entrant's registered email address, or by phone. VRC encourages Successful Entrants to check their junk email inbox in case the Confirmation Email is caught by spam filters. Such Confirmation Email shall contain further details of the Event including any requirements or recommendations for members and their guests prior to the Event. Unsuccessful Entrants will not be charged.</p> <p>Successful Entrants will be offered Ticket(s) to the Event in accordance with their entry. Payment for any Ticket(s) to the Event will become due once the Entrant has been notified that they are a Successful Entrant by VRC.</p> <p>To purchase the Event Ticket(s), a Successful Entrant agrees to pay VRC :</p> <ul style="list-style-type: none"><li>• VRC Member Ticket Price: \$185</li><li>• VRC Member Guest Price: \$210</li></ul> <p>A Successful Entrant may purchase a maximum of two (2) Tickets to the Event with a minimum of one (1) ticket holder required to be a VRC member.</p> <p>Successful Entrants will be contacted by VRC Membership Services team via phone to confirm and make payment. The full amount must be paid in one (1) transaction and paid over the phone by no later than 5:00pm Monday 28 April AEST. For the avoidance of doubt, any Successful Entrant's Ticket(s) which have not been paid for by 5:00pm Monday 28 April AEST will be deemed to be unclaimed and the Tickets will be redrawn in accordance with item G below.</p>
<b>G. Redraw (if unpaid):</b>	<p>The redraw for any tickets that remain unpaid by 5:00pm Monday 28 April 2025, will be conducted in the same manner as set out in Item E above and will be drawn at 10am Tuesday 29 April 2025.</p>

### Registration Terms

1. Eligible Entrants are eligible to register to attend the Event for themselves and one (1) guest
2. Places at the Event are subject to availability. For avoidance of doubt, a registration does not guarantee ticket or entry to the Event.
3. The Event will be hosted by the Melbourne Cricket Club (**MCC**) in the MCC Committee Room, on Sunday 18 May 2025
4. Registrations must be made online via [vrc.com.au/forms/mcg-match-day-registration-form/](http://vrc.com.au/forms/mcg-match-day-registration-form/)
5. The Event Promoter is Victoria Racing Club Limited (ACN 119 214 078) of 448 Epsom Road, Flemington VIC 3031.
  1. By completing the Registration, Members will be deemed to have accepted and agreed to these Terms & Conditions and the Member's Events Terms & Conditions located at [www.vrc.com.au/about-vrc/terms-and-conditions/](http://www.vrc.com.au/about-vrc/terms-and-conditions/).
7. Entry is only open to Eligible Entrants as described at Item B ("Eligible Entrants", "entrant"). Employees, directors and other representatives of the Promoter and organisations involved in sponsoring or conducting this Registration/Event (and any individuals so involved) are ineligible, as are members of their immediate families and households.
8. To Register Eligible Entrants must follow the instructions detailed under Item D. Only one entry is permitted per person.
9. Incomplete, inaccurate, illegible or photocopied entries will be deemed invalid. The Promoter accepts no responsibility for lost, late or misdirected entries. The Promoter reserves the right to verify the validity of entries and to disqualify any entrant who tampers with the entry process or submits inaccurate details.
10. Each Successful Entrant ("Event Attendee", "successful entrant") will be drawn on the date set out under Item E and the Promoter will notify the Successful Entrant via phone and in writing. If the Successful Entrant is not able to be contacted, does not make full payment of the Event Ticket(s) or is ineligible to claim the Ticket(s) pursuant to clause 7, the Promoter at its discretion, will redraw the Entries in accordance with and on the date set out in Item G (where applicable), and award the unclaimed or unpaid Ticket(s) to the next eligible entrant (the "alternate successful entrant"). If an alternate successful entrant is drawn and that alternate successful entrant is not able to be contacted or does not claim the Ticket(s) within 10days of the redraw, the Promoter, in its sole discretion, will forfeit the Ticket(s) and no substitute will be offered.
11. Successful entries of the Random Draw(s) are determined by chance. Skill plays no part in determining the winner.
12. If the Ticket is not available for collection at the Event, the Ticket will be delivered via email by the date agreed between the member and the Promoter.
13. The Ticket(s) will be awarded to the person named in the entry. The Promoter reserves the right to require the successful entrant to provide proof of age, identity and residency. Identification considered suitable for verification is at the discretion of the Promoter and the Promoter reserves the right to disqualify any person who fails to provide the required information or provides false information.
14. Once a Ticket(s) has been claimed by the VRC Member and has been delivered via email to the members email address the Promoter takes no responsibility for the Ticket(s) being damaged, delayed or lost.

- and not the Promoter. To the extent of any inconsistency, the terms and conditions of the Event supplier will prevail over these Terms and Conditions of Entry.

Cancellation of a ticket holders attendance at the Event will only be accepted where received a minimum of 5 business days prior to the Event and can be done so by contacting Membership Services in writing (email) at [membership@vrc.net.au](mailto:membership@vrc.net.au) or by phone on 1300 727 575 . Subject to VRC discretion, no refunds will be given for cancellations that occur after this time or for non-attendance at the Event.
  17. Members agree and acknowledge that the VRC will not issue any refunds for any payment made by a Member under any circumstances except in accordance with clause 3 of the Members' Events Terms & Conditions located at [www.vrc.com.au/about-vrc/terms-and-conditions/](http://www.vrc.com.au/about-vrc/terms-and-conditions/).
  18. Successful Entrants are advised that tax implications may arise as a result of accepting their ticket(s). The Promoter is not responsible for such tax implications and successful entrants should seek independent financial advice where necessary.
  19. All ancillary costs and expenses in claiming any Ticket are the responsibility of the Event Attendee (unless expressly stated).
  20. The entrant warrants and represents that any material sent or provided by the entrant to the Promoter will not infringe any copyright, trademarks or other intellectual property rights of any third party (including moral rights) and that the entrant has all rights to use the materials and has obtained all necessary consents to comply with any relevant privacy and/or confidentiality requirements.
  21. The Promoter collects personal information from entrants in order to facilitate the Random Draw. Entrants' personal information may also be provided to third parties (including Event Holder) for the purpose of administering this Registration/Event. If the information requested is not provided, the entrant may not be eligible to participate in the Event. The Promoter will handle personal information disclosed by the entrant in accordance with the Australian Privacy Principles under the Privacy Act 1988 (Cth) and the terms of its privacy policy located at <http://www.flemington.com.au/privacy-policy/>. Where applicable, unless the entrant has "opt-ed out", the entrant agrees that the Promoter may use this information in any media for future promotional, marketing and publicity purposes, including the sending of electronic messages.   22. The Promoter is not responsible for any problems or technical malfunctions of any telephone network, computer online systems, servers, or providers, computer equipment, software, technical problems or traffic congestion on the internet or at any website, or any combination thereof.
  23. If for any reason the Event is not capable of running as planned, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Event and invalidate any affected entries and no refund, cash, or alternative tickets will be substituted for failure for the Registration or Event to run. The Promoter accepts no responsibility or liability for any delay or failure by the third party to deliver the Event, any delay or failure relating to the Event itself (including any negative encounter experienced by the entrant including but not limited to cancellation, changes or delays of flights or other transport arrangements, inclement weather or any illness experienced) or failure by the third party to meet any of its obligations in Terms and Conditions of Entry or otherwise.
  24. The Promoter will not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) in connection with this Registration/Event, or for personal injury suffered or

sustained as a result of receiving or using a Ticket, except for any liability which cannot be excluded by law (in which case that liability is limited to the minimum allowable by law).

To the fullest extent permitted by law, the entrant releases and will release the Promoter from all claims that the entrant may have or may have had but for this release arising from or in connection with the entrant's participation in the Registration or Event (including Ticket(s)) and will indemnify and will keep indemnified the Promoter in respect of any claim by any person

arising as a result of or in connection with the entrant's participation in this Registration or Event..

26. The Promoter reserves the right to disqualify entries in the event of non-compliance with these Terms and Conditions of Entry.
27. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of these rights.
28. The Promoter's decision is final and no correspondence or communication will be entered into.
