



# Terms & Conditions

## 2023/24 Member Renewal Prize Draw Promotion

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
  2. Entry is only open to Australian residents aged 18 years or over who are current VRC Members in one of the following categories: Life, Pre-79, Full, Restricted, Young or Young Restricted (“**Eligible Entrants**”).
  3. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter.
